



Notification of Foreign Activity Form

Attached is the standard international Notification of Foreign Activity form for the Harry Fox Agency, Inc. (HFA), which has been devised to facilitate the collection of mechanical royalties due from releases in foreign territories in which you have designated HFA to act as your agent.

Only one product (e.g., album) title should be listed on each form, so please feel free to make additional copies. To ensure that your publishing interests are accurately represented, we ask that you complete the form(s) completely as indicated, typed or neatly printed, indicating in which specific territories the recording was released.

If possible, please attach label copy and/or any other supplementary material related to the foreign release(s) that you have, and return all materials to my attention in the Publisher Services Department. Upon receipt of your information, we will contact our affiliates in the appropriate territories. Please note that international royalty collection generally takes longer than domestic, as each society may have a different collection schedule.
